The problem that arose yesterday involved a critical failure of infrastructure that would have been beyond anyone's ability to rectify during the meeting.

Until then, please know that we will continue to do everything within our power as a presbytery staff to ensure the best possible hybrid meeting experience for both in-person and online participants. Dear Friends,

If you missed this week's presbytery meeting, here is what you missed! First, you missed a delightful spread of cookies and savories provided by our hosts. Pastor Steve Brand of the First Presbyterian Church of Washington Court House welcomed us. You also missed a chance to shake hands, give hugs, and share smiles with other Presbyterians from throughout the presbytery. The sanctuary was decorated for the Advent/Christmas season, it was warm, and you could feel the love of God in our midst. We worshiped God,

we celebrated the Lord's Supper, and we continued to look for HOPE, the theme of this past year's messages.







We approved the Structural Design for Mission and Ministry proposed by the Discernment and Design Administrative Commission, and we dissolved their commission with the presbytery's thanks and appreciation. We will now begin the implementation of the structural design, which will be in effect on April 1, 2024. We proposed some changes to the by-laws, with the new design plan in mind, which will be brought for second read and vote in February. If you have any questions or suggestions related to the by-law's updates, please let me know as soon as you can.













We recognized Deb Patterson's retirement from active ministry, we moved two inquirers (Brittany Porch and Susan Fisher) to candidacy as they move toward ordination as Ministers of Word and Sacrament, and we approved Nikki Hogarth for ordination to a call at Dublin Pres. (Watch for details of when this will happen - most likely January.)

Board of Pensions representative Luke Choi brought to our attention the Board's Emergency Grants. There are many different grant programs available, and they are open to anyone who has even one Board benefit (so as inexpensive as the vision care program). Luke mentioned that BenefitsConnect website is down for an overhaul, which should be back up in January. In the meantime, any need for answers, call 1-800-PRESPLAN (800-773-7752).

We approved the dates of next year's presbytery meetings, elected some folks to serve in various ways in the presbytery commissions and committees, and re-elected corporate and ecclesial officers. My contract was also renewed for 2024. Final order of business was to install the Moderator and Vice Moderator for 2024 (Steve Watters and Joel Esala).

Like I said...if you missed it, you missed a lot. I hope you'll put February 20 on your calendar and be present at the next meeting. The meetings are not limited to only elected commissioners and ministers. The meetings are also open to guests...see you soon!



The first Christmastide videos of the Presbytery's Public Domain Hymn project are available!

While many of our congregations across the USA have been without regular musicians for years, it was during the height of the COVID-19 pandemic that this became more widely problematic. To ease this burden, the Presbytery of Plains and Peaks has embarked on a project to bring all of the Public Domain hymns in our denominational hymnal, *Glory to God*, to our congregations for a small donation.

We've started with the hymns for Christmas and will move on to the other pubic domain hymns in the new year. Working with a church musician, hymns were recorded in MIDI format and then imported into editing software so that lyrics and backgrounds could be provided. Each hymn is available with white lyrics on a black background, or with white lyrics on a colored background. We are asking for a nominal donation of \$3 per hymn (whether black & white or with a colored background) to help offset the cost of producing the videos.
